

**PRISON RAPE ELIMINATION ACT (PREA) ANNUAL REPORT
FIRETREE, LTD.
2021**

Introduction:

The Prison Rape Elimination Act (PREA) of 2003 was enacted federally in an effort to prevent and address incidents of sexual abuse in criminal justice contracted facilities. This Firetree, Ltd. PREA Annual Report covers the period of calendar year 2021 and is the seventh such report for Firetree, Ltd. since PREA implementation in 2015.

The compiled data in this PREA Annual Report is based upon received PREA allegation incident reports, as well as upon investigation outcomes and completed PREA Incident Reviews.

The compiled PREA data for calendar year 2021 is applicable to Firetree, Ltd.'s drug and alcohol treatment facilities, as well as residential re-entry centers contracted with the PA Department of Corrections and/ or the Federal Bureau of Prisons. Specific facilities are identified as follows:

Re-entry Programs: Capitol Pavilion Scranton Pavilion Syracuse Pavilion

Drug and alcohol treatment program: Conewago Pottsville

The compiled PREA allegations/ incident data specifically includes the following categories and parallels the data requirements set forth in the Bureau of Justice Statistics (BJS) Annual Survey of Sexual Victimization:

- Resident-on-Resident Nonconsensual Acts
- Resident-on-Resident Abusive Sexual Contacts
- Resident-on-Resident Sexual Harassment
- Staff-on-Resident Sexual Misconduct
- Staff-on-Resident Sexual Harassment

Analysis and Conclusions:

This is the seventh PREA Annual Report prepared by Firetree, Ltd. In an attempt to analyze outcome data more in depth, the data compiled this year is additionally presented relative to facility rather than only in terms of agency-wide outcomes. Data analysis results for calendar year 2021 are as follows:

- **Resident-on-Resident Nonconsensual Acts:**
No allegations occurred in this category for all the applicable Firetree sites for each of the past two years.
- **Resident-on-Resident Abuse Sexual Contact:**
Capitol Pavilion had one substantiated allegation in this category for each of the past 2 years. No allegations occurred for each of the past 2 years at other Firetree sites. No issues were found that could have contributed to the incident such as staff coverage or video coverage and that the facility took immediate action regarding separation.
- **Resident-on-Resident Sexual Harassment:**
One allegation occurred in this category for Capitol Pavilion. This allegation was determined to be substantiated both sexual abuse as well as sexual harassment. Conewago Pottsville had one substantiated allegation in this category and Syracuse Pavilion had one unsubstantiated allegation in this category. As a result of an analysis of the Conewago Pottsville incident in terms of monitoring, the exterior door alarm system was enhanced. Syracuse Pavilion had one unsubstantiated allegation in this category.
- **Staff-on-Resident Sexual Misconduct:**
Capitol Pavilion had two allegations in this category with one allegation having been determined as unsubstantiated and the other one pending determination. No other applicable Firetree program had any allegations in this category.
- **Staff-on-Resident Sexual Harassment:**
None of the applicable Firetree programs had any allegations in this category for 2021 which was a decrease from a total of two allegations for the prior year.
- **Total number of allegations as compared to historical data:** The number of agency wide PREA allegations for 2021 was a total of 4 allegations as compared to the 2020 total of 7.
- **There were no PREA defined incidents during calendar year for Scranton Pavilion that began operations in July of 2021. However there was one allegation that was subsequently determined to not fit the definition of a PREA allegation that necessitated additional search training.**

Firetree, Ltd. continues its commitment in providing safe facility environments, as well as emphasizing the importance of maintaining a proactive and responsive approach to PREA allegations and requirements. This commitment should serve well in improving upon sexual abuse and sexual harassment incident outcomes.
